- That to undertake students' internship based on academic requirement.
- That to publish research books, books chapters, general publication media and other academic journals in collaborative mode between the teachers.
- That to use learning environment as a platform for providing information and communication technology.
- That the students will be made to comply with the politics of both institutions.
- That to utilize the library resources of both the colleges by students and teachers.
  - That to organise extension education programme in collaborative mode for the benefits of the students.
- The MoU will be valid for a period of 3 years before renewal.
  - Both the parties may review the outcome of the MoU from time to time, but neither party can terminate the MoU before the completion of any academic session.
  - Modification: The parties may change or modify the terms of this agreement only by written amendment signed by both the parties.
- Settlement of Disputes: Any dispute concerning interpretation of an application of this MoU shall be settled amicably through consultation or negotiation between the parties.
