This MEMORANDUM OF UNDERSTANDING is made on this 16th June, 2022 at Ramkrishna Nagar, Karimgnj, Assam

-BETWEEN-

Department of Sociology, Ramkrishna Nagar College, situated at Ramkrishna Nagar, Karimganj, Assam, Pin-788119 represented by its Principal namely **Debojani Naug** hereinafter called the **FIRST PARTY**

AND

Department of Sociology, West Silchar College, situated at Bajatrapur, Cachar, Assam, Pin-788110 represented by its Principal Dr. Sayed Ahmed Barbhuiya hereinafter called the **SECOND PARTY**

WHEREAS the FIRST PARTY and the SECOND PARTY have made this MEMORANDUM OF UNDERSTANDING for collaboration and students' exchange programme under the following terms and conditions.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS:

1. That to organise orientation lectures for overall development of students and teachers.
2. That to organise Faculty Development Programme in Collaboration mode.
3. That to share Knowledge, information and resources and creating opportunities for collaboration in research works.
4. That to undertake students' exchange programme for academic purpose.
5. That to offer faculty exchange programme for a stipulated period for academic purpose.
6. That to undertake students' internship based on academic requirement.
7. That to publish research books, books, books chapters, general publication media and other academic journals in collaborative mode between the teachers.
8. That to use learning environment as a platform for providing information and communication technology.
9. That the students will be made to comply with the politics of both institutions.
10. That to utilize the library resources of both the colleges by students and teachers.
11. That to organise extension education programme in collaborative mode for the benefits of the students.
12. The MoU will be valid for a period of 3 years before renewal.
13. Both the parties may review the outcome of the MoU from time to time, but neither party can terminate the MoU before the completion of any academic session.
14. **Modification:** The parties may change or modify the terms of this agreement only by written amendment signed by both the parties.
15. **Settlement of Disputes:** Any dispute concerning interpretation of an application of this MoU shall be settled amicably through consultation or negotiation between the parties.

The above mentioned norms of MoU will be applicable only for UG students of Sociology of Ramkrishna Nagar College and West Silchar College
